

CALL TO ARTISTS – FLORAL FUSION

FRIENDS OF JONATHAN DICKINSON STATE PARK ANNOUNCE AN EXCITING EVENT AND OPPORTUNITY TO SELL YOUR ART!

THE EVENT WILL CONSIST OF THREE PARTS:

- A flower show January 9-11, 2015, consisting of live orchids and floral exhibits
- A show of two (painting, photography, mixed media) and three (sculpture, glass) dimensional art work, on display in the gallery of the Elsa Kimbell Environmental Education and Research Center in the park from January 9–February 20, 2015
- A show of live plein air painting

DETAILS

- All work submitted must have a floral theme depicting flowers and/or floral arrangements. Work may be impressionistic as long as a floral theme is clearly discernible.
- Work will be juried to ensure consistency with quality, theme, showing space, and acceptability within the park's family-oriented, natural environment.
- Entry fees and registration for two and three dimensional art is \$20 per artist for up to three (3) and \$5 for each additional work. Fees must be paid at www.floralfusion2015.eventbrite.com. At time of payment via Eventbrite, you will be asked to enter the title(s) of works, sizes and prices. Accordingly, this information should be available.
- Entry fee for eligible plein air painters is \$10 per canvas. Plein air painters must supply their own materials and easels.
- An image of the work submitted for show must be received electronically by December 16, 2014. Images should be in JPG format and of sufficient quality and resolution to allow for proper review (minimum 72ppi and between 1000ppi and 2000ppi on the longest side.)
- Images submitted via email should be addressed to friendsjdsp@gmail.com. Images should be labeled last namefirst name_sequence number_image title.

- Submissions must be accompanied by registration and release forms if required.
- Accepted two dimensional works must be framed and be wired for hanging. Sawtooth hangers will not be accepted.
- 3D art must be accompanied by the proper display.
- Plein air participants will be selected on a first-come, first-served basis determined by space available. As the orchid display will run until January 11, painters' spaces will be assigned each day.
- 20% of the sale price of work sold is donated to the Friends of Jonathan Dickinson State Park, Inc., a non-profit 501(c)(3) organization (donations are tax deductible.)
- Artists will be notified if their work is selected by December 22, 2014. If accepted, work can be delivered starting December 26, 2014 and up to January 6, 2015.
- Art work that portrays recognizable people must be accompanied by a photo/model release form.

- Artists are responsible for all financial arrangements and delivery of artwork to buyers.
