Submissions can be made starting Tuesday, September 1, 2016 and must be in by Saturday, October 1, 2016 @ 5:00 pm USA Eastern Time at Pelican Community Park located at 18115 N Bay Road, Sunny Isles Beach, FL 33160 or the Visitor Center at the Sunny Isles Beach Government Center located at 18070 Collins Avenue, Sunny Isles Beach, FL 33160.

A panel of judges will evaluate all paintings entered on their artistic work and how they represent the Sunny Isles Beach Jazz Fest and portray the spirit of Jazz music.

PROFESSIONALS and AMATEURS welcome.

The contest is open to all ages; residents, and non-residents of Sunny Isles Beach. There is a limit of 2 entries per person.

SUBMISSION MUST BE A PAINTING using watercolors, acrylics, or oil based paints. Marker, crayon, chalk, or other non-paint based works will not be accepted. Digital artwork is also not acceptable.

With each painting submitted, please include the following on the back:

1. Artist's name.
2. Artist's address.
3. Artist's telephone number.
4. A title for the painting.

3. Entries that do not conform to the entry guidelines or fail to provide the requested completed waiver form may be removed from consideration.
