

Dear Artists & Arts Organizations,

On March 25th, the U.S. Senate approved a \$2.2 trillion emergency relief package designed to support the U.S. economy and provide critical investment in resources to help hospitals contend with the COVID-19 outbreak.

Within the bill is a \$75 million emergency appropriation for the National Endowment for the Arts (of which 40% is directed to state and regional arts organizations) to help the agency address the serious impacts experienced within the arts community as a result of this crisis. There are other provisions within the bill that will benefit artists, both as individuals and as business owners, including credits of \$1,200 to most American adults and \$500 for most children, as well loan forgiveness for organizations and businesses that retain workers and an expansion of unemployment benefits.

This editorial on Artnet News provides some specific details for us all in understanding how this may help each of us. It also succinctly addresses why it is important to support the cultural sector with the relief package. Many of us are employed in this sector, whether it be as an employee of a nonprofit organization or small business or a self-employed artist (writer, musician, dancer...etc). We were among the first to be impacted: asked to close our doors to crowds, to cancel our performances, etc. Do not let the political rhetoric get you down, instead be a positive force and be compassionate. As so many have said we are living in in unprecedented circumstances.

To assess our local impact, Miami-Dade County Department of Cultural Affairs has just shared a brief survey they are using to assess the damage and impact in their cultural sector. I am reviewing that document now and may be asking you to provide some data for our own, Martin County assessment. In the interim, I appeal to you to do the survey noted below with Americans for the Arts. Their dashboard can be sorted by zip code to get information for our community. It includes data for both organizations/businesses and individual artists.

These are trying times for all of us. PLEASE continue to share the amazing online resources you are creating so we can promote them and encourage families, near and far, to access them to decrease some of the stress, anxiety and boredom that is associated with our social distancing efforts and digital school/workplace initiatives. The power of the arts is so clearly evident in our nation as each of us personally does our part to stay safe and healthy from this virus. Thank you for all you do. Stay well.
